

<b>How It Works</b>	Concrete Shield seals the capillaries of the concrete, protecting it against harmful chemicals and stains, while still allowing it to breathe.
<b>Application</b>	<ol style="list-style-type: none"><li>1 Remove all oil, dirt, debris and efflorescence prior to sealing and let dry.</li><li>2 Ensure that Concrete Shield is only applied when there is no risk of rain within the next 6 hours.</li><li>3 Do not apply in extremes of temperature (below 40 F or above 110 F).</li><li>4 Apply to surface of concrete liberally and spread all surpluses with a heavy nap roller. A low pressure garden type sprayer may be used to apply Concrete Shield. Back brushing is recommended.</li><li>5 Accurate application rates are critical (typically 150 – 200 sq ft per gallon). Do not thin.</li><li>6 Avoid walking on the sealed area for 2 hours after application and do not drive motor vehicles on the surface for 24 hours.</li><li>7 <b>ALWAYS WEAR PROTECTIVE GLOVES AND GOGGLES. NO SMOKING. WEAR A MASK WHEN WORKING IN CONFINED AREAS.</b> Please refer to current MSDS.</li><li>8 All uncured spillages/splashes, and all tools must be cleaned immediately. Use warm soap and water for cleanup.</li></ol> <p><b>APPLICATION NOTE:</b> It is recommended that you test a small area to assure satisfaction of appearance.</p>
<b>First Aid</b>	If swallowed, give large quantities of water to dilute and call a physician. In case of eye contact, rinse immediately with water for 15 to 20 minutes. For skin contact, wash thoroughly with soap and water. <b>KEEP FROM FREEZING - KEEP OUT OF REACH OF CHILDREN</b>
